



## Corporate Wellness Membership Program

**What and Why:** We encourage people to get healthy and stay healthy. For every \$1.00 a corporation spends on health and wellness programs, it is returned to them **3.5-7 times!** How many ways does your business turn \$1.00 into \$3.50-\$7.00? That is a good investment! If you institute a wellness program, over time, your corporation may notice: more productivity, less stress, less worker's compensation claims, fewer sick days used. Best of all...happier, healthy people!

**Be proactive. Why wait to get sick?** At Village Health Services we agree with the philosophy of traditional Chinese medicine: you pay us to keep you HEALTHY, rather than waiting to pay us more when you are sick! Achieving and maintaining health and wellness takes time and devotion to self-care.

**How much?** Membership prices range from \$300-\$900 per month. You choose the level of participation based on how many employees you have and how much you want to offer them. **This membership is a deductible business expense, just like any other health care cost. This is not insurance or an insurance premium program. This is a discount program for receiving services at our clinic.**

**Our free gift.** We believe it is important to understand the authentic individual who comes to us in the totality of their mind, body, spirit and emotions. Each person is the expert on their own life and together we help them define and reach their health care goals. Each person who comes to our clinic can request a free health and wellness assessment (valued at \$175). This agreement details which program you have selected and for how long. Please read the following. If anything is unclear, please ask.

This Agreement is made today between Village Health Services and the company, agency or organization ("Corporation") named at the end of this document. The corporate membership program in which you are about to enroll includes the following options. Please select the membership level and time period.

\_\_\_\_\_ \$900 Our Diamond level members receive 180 service units (9-15 people=\$60/person or more/mo)

\_\_\_\_\_ \$500 Our Ruby level members receive 100 service units (4-8 people=\$62.50/person or more/mo)

\_\_\_\_\_ \$300 Our Emerald level members receive 60 service units (1-3 people=\$100/person or more/mo)

Please add \_\_\_\_\_ service units @ \$5 each to our monthly contract=\$\_\_\_\_\_ per month

A one time administrative set-up fee of \$50 will be added to initiate this program.

Service sessions are valued at different unit rates. Some services requiring more time or expertise are valued at higher unit values (a massage starts at 10 units, while an initial visit with our acupuncturist is 17 units). Please refer to the chart at the end of this document for more details. **For each service unit, you will receive a token redeemable only at Village Health Services.**



**Tokens must be used before the end of each calendar year. We will change the tokens each year. Village Health Services is not responsible for lost or stolen tokens. If the monthly payment option is chosen, tokens will be delivered monthly after payment is received. Lock in these rates with a one year contract, as rates are reviewed annually and will likely increase.**

### **PROGRAM RULES**

1. There is a minimum commitment of \$300 per month for at least 3 months.
2. The corporation pays a one time administrative set-up fee of \$50.
3. The corporation may purchase more service units at \$5 each.
4. The corporation receives one token for each service unit redeemable only at Village Health Services. Tokens must be exchanged when the service is received by the individual.
5. You may give your employees any number of tokens you wish, to use as they wish by the end of the calendar year.
6. Individuals are responsible for making appointments for services.
7. Individuals must fill out all administrative forms for clinic services and are considered individual patient/clients of Village Health Services. Health Assessment forms, directions to the clinic, and the phone number to call to make appointments are all available online at: [villagehealthservices.com](http://villagehealthservices.com) under the new patient tab.
8. **All medical information is confidential and will not be shared with the corporation signing this agreement.**
9. **Village Health Services is not responsible for lost or stolen tokens. Treat them like money because that is what they represent.**
10. Individuals can use tokens as well as purchase individual memberships or services at the clinic.
11. Upon request, Village Health will provide a year end summary statement of payments.

If the terms of this Agreement are acceptable, please sign the acceptance below. By doing so, you acknowledge that: (1) you have received a copy of this letter agreement; (2) you have had an opportunity to discuss the contents with Village Health Services and, if you desire, to have it reviewed by your attorney; and (3) you understand, accept and agree to abide by the terms hereof.
